History**

Charles Avery Dunning was born in Croft, Leicestershire, England, in 1885. A farmer and general manager of the Saskatchewan Co-operative Elevator Company, Dunning served as a Liberal Party member in the Saskatchewan Legislature (1916-1926) and as a cabinet minister in the W.M. Martin Government (1916-1922). He was appointed leader of the Saskatchewan Liberal Party and was sworn in as Premier of Saskatchewan in 1922, and served in this role until 1926. From 1926 to 1930 and 1935 to 1939, Dunning served as a federal Member of Parliament and was a cabinet minister in the W.L. Mackenzie King Governments. He later was a business executive and chancellor of Queen's University. Dunning died in Montreal, Quebec in 1958.

**Biographical
Sketch/Administrative
History**

Charles Avery Dunning was born on July 31, 1885, in Croft, Leicestershire, England, to Samuel and Katherine (Hall) Dunning. He was educated at Leicester until age 11 when he left school and became an office boy at the local patent office. At age 14, he became an apprentice at an engineering firm. Dunning immigrated to Canada in 1902 and settled near Yorkton, North-West Territories, where he worked as a farm labourer. In 1903, he was granted entry on a homestead at NE 20-26-6 W2 in the Beaverdale district.

As a farmer, Dunning was active in the Beaverdale local of the Saskatchewan Grain Growers' Association (SGGA). He was elected as a director of the SGGA in 1910 and as a vice-president in 1911. He was instrumental in the establishment of the Saskatchewan Co-operative Elevator Company, and served as its first general manager from 1914 until 1916.

In October 1916, Dunning was appointed by the Premier of Saskatchewan, W.M. Martin, to serve as Provincial Treasurer in his Cabinet. Dunning was first elected to the Saskatchewan Legislature in a November 1916 by-election as the Liberal Party Member of the Legislative Assembly (MLA) for the Kinistino constituency. He was elected as the MLA for the Moose Jaw County constituency in 1917 and was re-elected in 1921 and 1925. In addition to his portfolio as Provincial Treasurer (1916-1926), Dunning served as Minister of Railways (1917-1919, 1922-1926), Minister of Telephones (1918-1919), Minister of

Agriculture (1919-1920), Provincial Secretary (1921-1922), Minister of Municipal Affairs (1921-1922) and Minister-in-Charge of Labour and Industries (1921-1922). Upon the resignation of Martin as Premier on April 5, 1922, Dunning was appointed leader of the Saskatchewan Liberal Party and was sworn in as Premier of Saskatchewan and President of the Executive Council. During its mandate, the Dunning Government ended prohibition, by result of a 1924 plebiscite on the issue, and established a provincial liquor board aimed at controlling the sale of alcohol. It also oversaw the establishment and early growth of the Saskatchewan Wheat Pool.

On February 26, 1926, Dunning resigned as Premier and MLA to accept a federal post as Minister of Railways and Canals in the W.L. Mackenzie King Cabinet. He served in this role in two separate terms between 1926 and 1929, and as Acting Minister in late 1929. He also served as Minister of Finance and Receiver General in two separate terms between 1929 and 1939, Dunning was elected as a Liberal Party Member of Parliament (MP) for the Regina constituency in 1926 and served until his defeat in 1930. He was elected as a Liberal MP for the Queen's constituency in Prince Edward Island in 1935 and served until his retirement from politics in 1939.

After leaving politics, Dunning relocated to Montreal, Quebec and was appointed president and chief executive officer of Ogilvie Flour Mills, a position held until 1947. He also sat on the boards of various other corporations and financial institutions. Dunning was appointed chancellor of Queen's University in 1940 and served in this role until his death on October 1, 1958 in Montreal. He was interred at Mount Royal Cemetery in Montreal.

Charles Dunning married Ada Rowlatt on July 3, 1913. They had two children: Katherine and Avery. Ada Dunning died in Montreal on December 2, 1963.

Dunning from 1916 to 1926 during his political career in Saskatchewan as Provincial Treasurer (1916-1926), Minister of Railways (1917-1919, 1922-1926), Minister of Telephones (1918-1919), Minister of Agriculture (1919-1920), Provincial Secretary (1921-1922), Minister of Municipal Affairs (1921-1922), and Premier and President of the Executive Council (1922-1926).

The fonds also consists of photocopies of records held by Queen's University Archives in its Charles Avery Dunning fonds that relate to Dunning's political career in Saskatchewan.

This fonds contains public and private records.

No series assignment has been applied to the records in this fonds.

INTRODUCTORY NOTE TO THE C. A. DUNNING PAPERS

Charles Avery Dunning was born in Croft Leicestershire, England on July 31, 1885. He came to Canada when he was seventeen years of age and found employment on a farm near Yorkton, Saskatchewan. After gaining some experience in agriculture he filed on a homestead near Beaverdale, Saskatchewan. He was a successful farmer and a prominent member in farmers' organizations and in 1911 he became general manager of the Saskatchewan Co-operative Elevator Company, Limited.

Upon the formation of the Martin Ministry in Saskatchewan on October 20, 1916, Mr. Dunning assumed the portfolio of Provincial Treasurer. Other departments which he headed at one time or another in the Martin Cabinet were those of Railways, Agriculture, Telephones, Municipal Affairs and Provincial Secretary. Mr. Dunning became Premier of the province on April 5, 1922 and remained in that position until he resigned on February 26, 1926 to become a Minister in the Federal Cabinet.

The papers which the Archives received relating to Mr. Dunning's activities as a Provincial Cabinet Minister were arranged under subject heads, with no number filing system apparent. His papers as Premier were characterized by a number filing system; "Y" followed by two numbers. The first number after the "Y" designated a main subject head such as agriculture; the second number indicated sub-heads under the main topics. For the most part main topics were arranged alphabetically. The Archives has preserved this arrangement. Many of the subject heads in his ministerial papers (1916-22) were the same or similar to those in his premier's papers (1922-26), and some of the correspondence in the latter also was a continuation of that which he carried on as a minister of the Martin Cabinet. His ministerial papers (1916-22) therefore have been incorporated into the filing system of his premier's papers, but with the letter "X" assigned by the Archives to distinguish them from the "Y" papers, and the necessary numbers added after the "X". In most cases the contents of the files remain virtually as they were received by the Archives.

In 1967 photocopies were obtained of material in the Dunning Papers at Queen's University relating to Mr. Dunning's activities while in Saskatchewan. This material has been arranged in a "Y" series following the numbering system used by Mr. Dunning. But the numbers are prefixed by [Q] to indicate their origin. These files are listed in an addenda to the Table of Contents and described in the section beginning on page 34 of this guide.
