Biographical Sketch / Administrative History	James K. Pankiw was born on August 7, 1966 in Unity, Saskatchewan. He attended elementary and high school in Unity. Pankiw earned a Bachelor of Science (Human Anatomy) degree from the University of Saskatchewan in 1988 and a Doctor of Chiropractic degree from the Canadian Memorial Chiropractic College in 1992. He achieved an Acupuncture Diploma from the International College of Acupuncture in 1996. Pankiw worked as a chiropractor in Saskatoon prior to his entry into federal politics in 1997.
	Pankiw was first elected to the House of Commons in 1997 and served as a Reform Party Member of Parliament (M.P.) for the Saskatoon-Humboldt constituency until 2000 when the party became the Canadian Reform Conservative Alliance Party (known as the Canadian Alliance). He was re-elected as a Canadian Alliance M.P. for Saskatoon-Humboldt in 2000 but left the Canadian Alliance caucus with several other caucus members in 2001 to form the Democratic Representative Caucus. After the other dissident members returned to the Canadian Alliance caucus in 2002, Pankiw served as an Independent M.P. until his defeat in the 2004 general election by Brad Trost (Conservative Party of Canada).
	Parliamentary positions held by Pankiw included: Industry Critic (1997-2001), Scrutiny of Regulations Critic (2001), and Public Works and Government Services Critic (2001-2002). Pankiw stood as a member of the Standing Committee on Industry (1997-1999), the Standing Committee on Canadian Heritage (1997-2000), the Standing Joint Committee on Scrutiny of Regulations (1999-2002), and the Liaison Committee (2001-2002). He stood as Chair of the Standing Joint Committee for the Scrutiny of Regulations (2001-2002).
	While serving as an M.P., Pankiw ran unsuccessfully as a mayoral candidate in the 2003 Saskatoon civic election. Pankiw also ran unsuccessfully as an independent candidate for the Battlefords-Lloydminster constituency in the 2006 federal election.
	Jim Pankiw and his wife Valerie have two daughters: Stephanie and Vanessa. He continues (2007) to reside in the Saskatoon area and practice chiropractic in Saskatoon.

Pankiw was first elected to the House of Commons in 1997 and as a Member of Parliament (M.P.) served the Saskatoon-Humboldt constituency for the Reform Party (1997- 2000), the Canadian Reform Conservative Alliance Party (2000- 2001), the Democratic Representative Caucus (2001-2002), and as an Independent (2002-2004). Pankiw was defeated in the 2004 federal election.
