The Committee was formed to examine the advisability of simplifying procedures under the Elections Act (1965) and the Controverted Elections Act (1965) and to make recommendations thereon. The records were accumulated between February and December 1969.

The types of records included are: briefs; correspondence; Election Acts; drafts of reports; minutes; notices and agenda; order of reference; research papers; and the Final Report of the Committee.
