Brief Bio./Admin. History

The Regina Little Theatre Society was established in Regina, Saskatchewan, in 1926. Its mandate was to foster the development of the spoken drama, to instruct amateurs in the art and technical aspects of drama, and to produce plays. Performances of one-act and full-length plays have occurred since 1926 at various venues in Regina, as well as participation in provincial and national theatre competitions. Currently (2011) the Regina Little Theatre Society continues as a non-profit community theatre company.

Biographical Sketch/Administrative History A provisional meeting of the Regina Little Theatre Society was held at the office of Read, Smith & Co. in Regina, Saskatchewan, on May 21, 1926. Those present were Capt. G.R. Chetwynd, H.E. Jones, A. Hall, A.J. Haggert, G. Meldrum and W.T. Read, who acted as chair. The purpose of the meeting was to decide if the formation of a new dramatic society was in the interests of the city and was feasible. A provisional executive was formed of those present along with E.A. Matthews.

The first general meeting of the Society was held at the Kitchener Hotel on June 7, 1926. At this meeting, an executive was formed comprised of Col. F.B. Ware - president, H.E. Jones - vice-president, W.T. Read - secretary, F.H.H. Smith - treasurer, and Mrs. Middleton, Mrs. Gilbert, Mr. Matthews, Mr. Middlemas and Mr. Haggert as additional members. It was determined that the objective of the Society was the development of the spoken drama; training and instruction of amateurs in the art of drama and in its technical branches; and the production of plays. Membership to the Society was set at two dollars per person.

The inaugural performance of the Regina Little Theatre (RLT) occurred on November 29, 1926, at the Regina College Auditorium. This performance was open to members only and featured two one-act plays. The first performance of a play open to the general public took place at the Grand Theatre in February 1927. In 1928, the newly-built Darke Hall became the site of performances for the Society. Darke Hall remained as the venue for numerous RLT productions until the 1988-1989 performance season.

Along with its local performances, the RLT also participated in the provincial Dominion Drama Festival in 1933 and annually thereafter until the Festival's end ca. 1971. The RLT won numerous awards for acting, directing and production at these festivals.

In 1956, the Society established the Regina Little Theatre Building Company Ltd. to provide facilities required for the accommodation of its activities. This company was incorporated under The Companies Act on March 5, 1956. Through the company, the Society acquired a building on South Railway Avenue for the purposes of rehearsals and storage. In 1988, the Society became a tenant of Theatre Regina Inc., the body that operates the Regina Performing Arts Centre. The Regina Little Theatre Building Company Ltd. was amalgamated with the Regina Little Theatre Society, Inc. on June 30, 1998.

The Regina Little Theatre Society, Inc. continues (2011) as a non-profit community theatre company. It produces five full-length main stage plays and two sets of one-act plays per year. It participates annually in Theatre Saskatchewan Inc.'s annual drama festival. It also holds drama workshops, play writing contests, and fundraising events, and provides scholarship opportunities for members who are studying performing arts. It receives funding through local government and corporate sponsorship and is affiliated with Theatre Saskatchewan Inc. and Theatre Regina Inc.

This fonds consists of records created, accumulated and used by the Regina Little Theatre Society in its operations from 1926 to 2004 as a non-profit community theatre company in Regina, Saskatchewan. It includes records relating to productions of the Regina Little Theatre, and competition at the provincial and national Dominion Drama Festival. It also includes issues of the Society's monthly newsletter "Masks & Faces". A small volume of records pertains to other theatrical organizations in Saskatchewan.

The types of records included are newsletters; minutes of meetings and conventions; clippings; programmes; membership lists; publications; reports; financial records; scrapbooks; and photographs.

No series assignment has been applied to the records in this fonds.

Introduction

The Little Theatre movement, inaugurated by Sir Barry Jackson in Birmingham, England, came into operation in Regina in 1926 with the formation of the Regina Little Theatre Society. Prior to this, amateur dramatic work had been fostered by the Regina Amateur Dramatic Society in 1912-1913, and afterwards by the Community Players. The objectives of the Society were the development of spoken drama, the training and instruction of amateurs in the art of the drama and in its technical branches and the production of plays.
