CERTIFICATE OF NATURALIZATION

IN THE SUPREME COURT OF THE NORTH-WEST TERRITORIES.

WHEREAS *Peter Flaman* of *Ou Appelle Assa* in the North-West Territories of Canada formerly of *Austria Europe* has complied with the several requirements of The Naturalization Act, and has duly resided in Canada for the period of three years. And whereas the certificate granted to the said *Peter Flaman* under the tenth section of the said Act has been duly presented to a Judge sitting in Chambers in the Judicial District of *Western Assa* and whereas a copy of such certificate has been duly posted in a conspicuous place in the Court House in which the said Judge holds his Chambers and whereas the said Judge has directed the issue of a Certificate of Naturalization to the said *Peter Flaman*

Provincial Archives of Saskatchewan

This is therefore to certify to all whom it may concern, that under and by virtue of the said Act, *Peter Flaman* has become naturalized as a British subject, and is, within Canada, entitled to all political and other rights, powers and privileges, and is subject to all obligations to which a natural-born British subject is entitled or subject within Canada, with this qualification, that he shall not, when within the limits of the foreign State of which he was a subject previous to the date hereof, be deemed to be a British subject unless he has ceased to be a subject of that State, in pursuance of the laws thereof, or in pursuance of a treaty or convention to that effect.

Given under the seal of the Supreme Court of the North-West Territories, Judicial District of *Western Assa* Saskatchewan this *fourth* day of *January* one thousand nine hundred and *five*.
