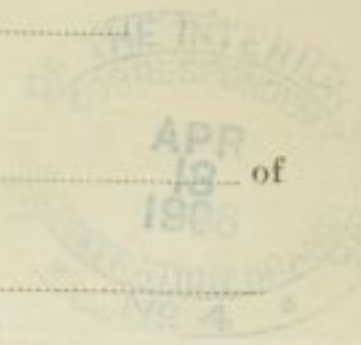

DECLARATION OF ABANDONMENT.

In the Matter of the South West of Section 28

do solemnly declare :-

That I made entry for the above mentioned lands at the Dominion Lands Office at Regina on the 19th day of April 1905, and I now ask to have said entry cancelled, and be permitted to take up another homestead for the following reasons, namely :

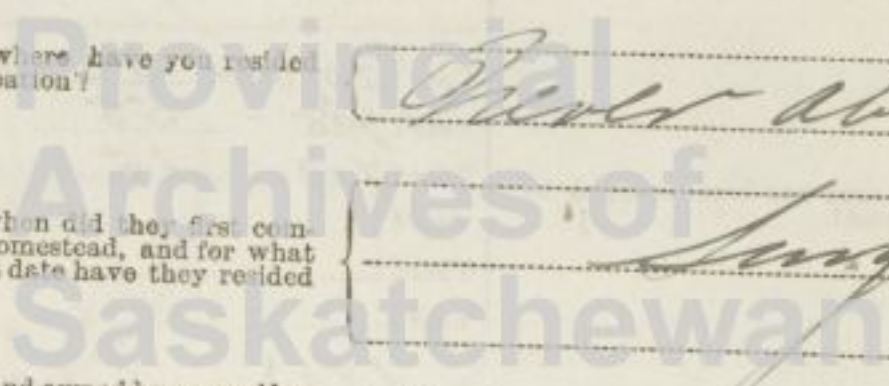
